## ➤ Guidelines for using this report

●	Moderate Risk	A <b>moderate risk</b> candidate is likely to have a <b>moderate fit</b> to jobs where step-by-step procedures, and adherence to safety policies are important
✖	High Risk	A <b>high risk</b> candidate is likely to have a <b>weak fit</b> to jobs where step-by-step procedures, and adherence to safety policies are important
✖✖	Very High Risk	A <b>very high risk</b> candidate is likely to have a <b>very weak fit</b> to jobs where step-by-step procedures, and adherence to safety policies are important
